52.212-2 EVALUATION--COMMERCIAL PRODUCTS AND COMMERCIAL SERVICES (NOV 2021)

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. Proposals will be evaluated based on best value to the Government. The following factors shall be used to evaluate offers:

- (i) Understanding of the Requirement (20 points);
- (ii) Technical Approach (20 points);
- (iii) Relevant Experience (20 points);
- (iv) Key Personnel Qualifications (15 points);
- (v) Management Capability and Quality Control (15 points);
- (vi) Past Performance (15 points)

The Government reserves the right to make a selection based upon initial offer without discussions; therefore, the offeror should submit their best terms in their initial offer. The Government also reserves the right to enter discussions and request revised offers if needed and may also determine to make no award.

(b) Options. The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).
